## MINUTES OF THE THIRD STATE LEVEL COMMITTEE MEETING FOR PRADHAN MANTRI CHA SHRAMIK PROTSAHAN YOJANA (PM-CSPY) HELD ON 21<sup>st</sup> NOVEMBER, 2024 UNDER THE CHAIRMANSHIP OF CHIEF SECRETARY, ASSAM.

The Agenda of the meeting is enclosed at Annexure-A.

The meeting was chaired by the Chief Secretary, Assam. The Additional Chief Secretary, Tea Tribes & Adivasi Welfare Department-cum-Convenor of the Committee apprised the members regarding the action taken on the Minutes of the 2<sup>nd</sup> meeting of SLC for the Pradhan Mantri Cha Shramik Protsahan Yojana (PM-CSPY).

- 1. Tea Tribes and Adivasi Welfare Department has forwarded the proposal received from the MD SSA which was approved by the SLC along with detailed plan and estimates and Non duplicity Certificate selected under the Component -1 i.e *Cha Shramik Shiksha Yojana (CSSY)* to the Ministry of Commerce and Industry, Govt. of India. Moreover, the TTAW Department has also received the Commitment certificate submitted by School Education Department for onward submission to the Ministry as desired.
- 2. Tea Tribes and Adivasi Welfare Department has also forwarded the proposal along with detailed plan and estimates in connection with procurement of Mobile Medical Unit as received from the MD NHM and as approved by the SLC selected under the Component-2, i.e Cha Shramik Swasthya Suraksha Yojana (CSSSY) to the Ministry of Commerce and Industry, Govt. of India. The Health and Family Welfare Department has submitted the Non-duplicity certificate to TTAW department. However, the commitment certificate is awaited for onward submission to the Ministry.
- 3. Tea Tribes & Adivasi Welfare Department has issued reminders to all concerned DCs for submission of report on selected/identified land for implementation of Component -3, i.e. *Cha Shramik Aashray Yojana (CSAY)*. Reports from two districts only viz. Sibsagar and Kokrajhar are received till date.
- 4. In respect of Component -3, i.e. Cha Shramik Aashray Yojana (CSAY), on receipt of information from the representative of Tea Board regarding the acceptance SLC's proposal by the Ministry in respect of implementing agency, Tea Tribes and Adivasi Welfare Department has communicated and requested the Commissioner and Special Secretary to the Govt. of Assam, PWD (Building) to prepare and submit 2-3 nos. of Model Plan & Estimates for approval of SLC.
- 5. The representative of Tea Board informed that the tender floated for establishment of PMU in respect of Component -4, i.e *Tea Board PMU* will be completed within short time.
- 6. The representative of PWD (Bldg) has informed that the Department has worked out a tentative estimate and a shed of around 300 sq. feet can be accommodated within the stipulated fund of Rs. 4.16 L per unit without Electricity and running water facility.

After threadbare discussion, the meeting resolved as follows -

- 1. The chairman has directed to submit the required Non-duplicity and Commitment certificate to the Ministry immediately.
- 2. As per the guideline of accommodating one, two and three Resting sheds for Tea Gardens upto 500 Ha, 500 700 Ha and above 700 Ha respectively as well as considering the number of available Tea Gardens in the state, around 2500.00 (Approx) no. of resting sheds can be constructed and as such, the state will be able to utilize around Rs.104.00 crore only against the component III of PM-CSPY and around a sum of Rs. 25.00 crore will remain as unspent amount.

Under the above circumstance -

- i) It is resolved to propose GoI to allow to utilize the unspent amount by increasing the Unit cost of each resting shed. (or)
- ii) If the unit cost enhancement is not allowed, then the state Govt. may be allowed to accommodate the unspent amount for utilization of schemes under the Component I&II of PM-CSPY which has necessity. (or)
- iii) If the above are not possible, approval may be considered for 2500 Units at an estimated cost of Rs.104.00 crore ( @ Rs.4.16 Lakh /Unit)
- 3. Since, approval of schemes under Component I, II and II are not yet received and the time for utilization of allocated fund for the FY 2024-25 is very short, the State may not likely be in a position to utilize the entire fund within the stipulated time i.e, 31<sup>st</sup> March, 2025. Hence, it is resolved to propose that GoI may allow to utilize the unspent amount of fund allocated for the FY 2024-25 in the next FY 2025-26.
- 4. The Tea Board will arrange to set up the PMU at the earliest observing all necessary formalities.
- 5. The next SLC Meeting will be held as and when necessitated.

The meeting ended with a vote of thanks from the Chair.
